

Wing Hang Bank Lowered its Prime Lending Rate by 0.25%p.a.

(7 November 2006, Hong Kong) Wing Hang Bank today announced that with effect from 8 November 2006, its Prime Lending Rate will be lowered to 8% p.a. from 8.25% p.a. HKD savings interest rate will also be lowered by 0.25%p.a. Please refer to the table below for details.
