

Wing Hang Bank Lowered its Prime Lending Rate by 0.25% p.a.

(9 November 2007, Hong Kong) Wing Hang Bank today announced that with effect from 12 November 2007, its Prime Lending Rate will be lowered to 7.25% p.a. from 7.50% p.a. HKD savings interest rate will also be lowered by 0.25% p.a. Please refer to the table below for details.
