

Wing Hang Bank Lowered its Prime Lending Rate by 0.25% p.a.

(12 December 2007, Hong Kong) Wing Hang Bank today announced that with effect from 13 December 2007, its Prime Lending Rate will be lowered to 7.00% p.a. from 7.25% p.a. HKD savings interest rate will also be lowered by 0.25% p.a. Please refer to the table below for details.
