NOTICE OF POTENTIAL EVENT OF DEFAULT

NOTICE to the holders of the Notes of Series 15B (XS0208476464) issued by Pacific International Finance Limited (the "Issuer") presently outstanding (the "Noteholders" and the "Notes," respectively).

This Notice will serve to advise that the Trustee has received a Notice of Non-Receipt of Payment from HSBC Bank plc in its capacity as Paying Agent for the Notes, a copy of which is attached hereto as Exhibit A. The Notice of Non-Receipt of Payment states that the Paying Agent did not receive unconditionally and in full the interest payment due in respect of the Notes on 29 December, 2008.

Failure to make a required interest payment on the Notes constitutes an Event of Default thereunder **if such failure continues for a period of 15 days after the scheduled interest payment date**. Accordingly, unless the Issuer makes the required interest payment on the Notes before 13 January 2009, an Event of Default will exist with respect to the Notes. Upon the occurrence of an Event of Default, the Trustee, if requested in writing by Noteholders representing 1/5 in principal amount of the outstanding Notes or directed by an Extraordinary Resolution¹ (subject in each case to being indemnified to its satisfaction), shall notify the Issuer that the Notes are immediately due and payable at their Redemption Amount, together with accrued interest thereon. If such amounts are not paid, the Trustee may be requested in writing by Noteholders representing 1/5 in principal amount of the outstanding Notes or directed by an Extraordinary Resolution (subject in each case to being indemnified to its satisfaction) to enforce the collateral for the Notes.

In addition, Noteholders will be aware that Lehman Brothers Holdings Inc. and certain of its subsidiaries have entered into certain protective bankruptcy or similar proceedings in various jurisdictions (the "Proceedings").

The Trustee, pursuant to the terms of the Trust Deed, is reviewing the situation and is considering its rights and powers under the Notes in light of the Proceedings. The Trustee may be seeking directions in due course from Noteholders in respect of certain matters relating to the Proceedings and possible actions it may take on behalf of the Noteholders in relation to the matters described above.

¹ The quorum requirement for a meeting at which an Extraordinary Resolution is being considered is two or more persons holding Notes representing in the aggregate a clear majority in principal amount of the Notes outstanding at such time. Any Extraordinary Resolution requires the approval of 3/4 of the Note Holders voting.

Noteholders are encouraged to review their individual positions and, if they are in any doubt as to the action they should take should consult their own independent professional advisers immediately.
